#### The Recognition Scheme:

- · aims to identify and raise awareness of good quality service provision and protect the public
- · forms part of COSCA's wider quality assurance work
- · recognises and endorses good practice within counselling, psychotherapy and counselling skills organisations in Scotland has been developed by COSCA through extensive consultation.





## Who is the Scheme for?

The Scheme has been designed for all organisations, both small and large, which provide counselling, psychotherapy and/or use counselling skills.



## Are we eligible?

#### To apply organisations are required to:

- have COSCA organisational membership.
- engage relevantly trained and supervised staff and volunteers
- abide by the COSCA Statement of Ethics and Codes of Practice
- utilise a Complaints Procedure which meets the COSCA Standards for Complaints Procedures.





## Why does your organisation need COSCA Recognition?

#### The Recognition Scheme offers organisations:

#### Credibility and the opportunity to evidence your organisations impact

- external recognition by the Scottish professional body for counselling and psychotherapy
- the opportunity to make a public statement about the quality of your organisation and the services it provides
- use of the Recognition Scheme Logo and listing on the Recognition
- a means of demonstrating your organisations impact to funders, please see COSCA'S website www.cosca.org.uk recognition- funders, for section dedicated to funders.

#### **Increased Organisational Focus**

- a reflective tool to increase organisational awareness and drive your organisation forward
- the opportunity to pull together policies and procedures into an easily accessible and clear framework across key organisational criteria

#### Dedicated one to one support to develop and maintain quality services

- support from Recognition Scheme Development Officer to develop policy and practice and to apply for and maintain Recognition Scheme Status
- access to support through various channels including telephone, email and Skype.

#### Ongoing Feedback and Monitoring

- assessment Report provides detailed feedback on key organisational criteria identifying strengths and recommendations for future organisational development
- annual Monitoring process provides ongoing feedback on organisational strength and areas for development promoting continuous organisational development

#### Organisations must fulfil standards in the following areas:

- Management, Recruitment, Health and Safety
- Confidentiality, Equal Opportunities
- Complaints, Grievance & Discipline
- Insurance, Finance
- Networking, Publicity
- Training & Personal Development
- Referral of Clients, Support & Supervision
- Record Keeping, Outcomes & Research



## How do we apply?

#### The Application Process:

The process contains 3 stages:

#### 1. Registration:

- To register your interest for the scheme please see the COSCA Website under the heading Recognition and click to 'Register your interest'
- Registration forms can be found in the COSCA Website www.cosca.org.uk- recognition

#### 2. Evidence Gathering:

- Collation of organisational and practice based criteria
- Verification of documents by Recognition Scheme Development Officer.

#### 3. Assessment

- Assessment Visit, Report and Independent Verification
- Entry into COSCA Register of Recognised Organisations.

#### 4. Annual Monitoring

- Submission of Annual Monitoring forms
- Verification by Recognition Scheme Development Officer
- 3rd Annual Monitoring Year Visit

Applicants and Recognition Scheme members will be supported at all stages of the above process by the Recognition Scheme Development Officer.
