#### Lay Representatives Application Briefing Pack

#### Introduction

Thank you for your interest in being appointed as a Lay Representative onto the Ethics Committee of COSCA (Counselling & Psychotherapy in Scotland). This application briefing pack sets out the information relating to the appointment of a Lay Representative. After reading the information, we hope that you will decide to apply to become a Lay Representative.

#### Why Become a Lay Representative?

Becoming a Lay Representative provides you with the opportunity to become involved and play an active role in the field of counselling and psychotherapy. This appointment is an important way for you to contribute to the advancement of counselling and psychotherapy in Scotland, improve your contacts and use and develop your skills and experience.

#### Role of Lay Representative

COSCA Ethics Committee Members, including Lay Representatives, are responsible on a voluntary basis to COSCA's Board for the development, review and implementation of COSCA's Statement of Ethics and Code of Practice. This Statement enshrines COSCA's thinking on the good practice of counsellors and psychotherapists. Working with the Chief Executive, the Committee is also involved in:

- organising and leading our annual ethical event
- assisting with the development of ethical guidelines as required
- the investigation of complaints against members of COSCA.

#### Requirements:

- not to be a counsellor or psychotherapist, a member of COSCA, or work for a member organisation
- to be able to work in a small team
- to be interested in public protection
- to have had some experience or knowledge of an ethical framework or set of professional standards
- to be able to understand and process ethical dilemmas.

The Ethics Committee usually meets 3 times per annum either in Stirling or online. Meetings are arranged in advance with Committee members and are two hours in length. The Chief Executive provides secretariat for Committee meetings and attends its meetings and events. The meetings are chaired by one of the members of the Committee. In accord with COSCA's volunteer expenses policy, agreed in advance out-of-pocket expenses can be claimed by members attending meetings and carrying out their roles as Committee members.

#### Lay Representatives – COSCA Complaints Panellists

Ethics Committee members, including Lay Representatives, also sit on COSCA Complaint Panels in a voluntary capacity. These panels decide on complaints submitted to COSCA about members including counsellors, psychotherapists, supervisors, counselling skills users, students and counselling/counselling skills organisations. No previous experience of working as a complaints panel member is required. Panellists will be obliged to adhere to the principle of confidentiality in carrying out their work. Panellists, working on a voluntary basis and in the interests of public protection, need to be able to:

- objectively examine written evidence in a constructive manner
- conduct interviews and analyse resulting evidence
- make decisions in a group setting based on evidence
- write reports
- be interested in public protection and work in a small team
- value the work done by counsellors and psychotherapists

#### **Conflicts of Interest**

Lay Representatives will be required to declare in their application any conflicts of interest and, if appointed, work within the COSCA Conflict of Interest Policy.

#### **Application Process**

You are invited to apply to become a Lay Representative by completing and signing the application form included in this Information Pack.
