Job Title: Wellbeing Support Worker Men's Service

Location: Based within GCA's Head Office in North Claremont Street with travel

throughout Glasgow City for service delivery.

Salary: GCA Salary Grade 5 £22,932 - £24,951 per annum (pro rata)

Hours: Part-time – 21 or 24 hours per week – Fixed term for 3 years

21 hours per week working pattern: 10:00am to 4:00pm Monday, Tuesday and Thursday and 9:00am to 4:00pm Friday.

24 hours per week working pattern: 9:00am to 5:00pm Monday, 1:00pm to 9:00pm Tuesday, 9:00am to 5:00pm Thursday and 9:00am to 12:00pm Friday.

We understand that many will have other commitments outside of work and so flexible working, part-time hours or job-sharing arrangements will be considered for the right candidate.

Please note; As this post will involve work in a men's only service, there is a genuine occupational requirement to ensure that we recruit male Wellbeing Support Workers and therefore these posts are only open to men (exempt under Schedule 9, Part 1 of the Equality Act 2010).

- Delivering one-to-one support in a person-centred manner, both out in the community and at GCA's head office
- Facilitating groups, both informal activity based groups and formal structured groups
- Providing psychoeducation
- Networking with partners
- Documenting appointments and tracking progress on the Views database

- Clean current UK Driving License and access to own car is desirable, but ability to travel citywide via public transport is sufficient
- A qualification in Health and Social Care or equivalent qualification is desirable, but candidates who clearly meet the criteria for the role but do not have this qualification will also be considered
